## Primary Care for Homeless Individuals: Can Lessons from VA Health Care Apply More Broadly?

### Screening for Social Determinants of Health in the Veterans Health Administration: Evolution, Current Practice, and Lessons Learned from the Nation's Largest Integrated Healthcare System

Social determinants of health (SDoH), including material hardship and exposure to violence, are common among Veterans. VA has invested heavily in screening for SDoH and is uniquely positioned to address these issues. This interdisciplinary session reviews the evolution of VA approaches to screening for SDoH and the research guiding it, with a focus on care in general medical and emergency department settings. Implementation lessons learned can inform future care both within and outside of VA.

### Supporting Community Reintegration After a Period of Incarceration: Reducing Disparities Through an Integrated Peer Support Intervention for Veterans

Presentations are designed to: raise awareness of health disparities among individuals who have been incarcerated; describe an integrated peer-support model that addresses these disparities; and share impacts based on implementation and outcome studies.

### The John M. Eisenberg National Award for Career Achievement in Research Eve Kerr, MD, MPH

This award recognizes a senior member whose innovative research has changed the way we care for patients, conduct research, or educate students. It is named for the late John M. Eisenberg, MD, MBA, because of his unique role as researcher, mentor, and Director of the Agency for Healthcare Research and Quality, where he was a strong advocate for research in general medicine.



### Quality & Practice Innovation Award

The award recognizes leaders of practice innovations who have improved care within the "quality" domains of the 2000 IOM Crossing the Quality Chasm report: safety, effectiveness, patient-centeredness, timeliness, efficiency and equality, or the Patient Centered Medical Home goals of accessible, coordinated, patient centered, team based, and comprehensive care. Recipients are general internists (and their organizations) who have successfully developed and implemented innovative systems of practice improvement in ambulatory and/or inpatient clinical practice.



### **Unified Leadership Training for Diversity (UNLTD)**

Founded by Dr. Mark Linzer, the Unified Leadership Training in Diversity Program is designed for junior and mid-career faculty from underrepresented groups to develop the complex skill sets required to successfully lead academic sections and departments. This program provides mentoring, a scholarship to attend the ACLGIM leadership training conference, and some financial assistance to offset expenses.
